## **Release and Waiver Agreement**

The term "WVUSG" used in this document shall refer to the West Virginia University Student Grotto (caving club).

The term "Participant" as used in this document shall refer specifically to the signee at the end of the document.

- 1) I am aware that participants of the WVUSG voluntarily engage in activities such as, but not limited to caving, climbing, camping, rafting, rappelling, skiing, snowboarding, biking, biking and swimming.
- 2) I am aware that the activities of a WVUSG event may be hazardous to my property and person. I am voluntarily participating in said activities with knowledge of the possible hazards involved, and hereby agree to accept any and all risks of property damage and personal injury.
- 3) As a Participant, I hereby release WVUSG, any of its members or participants, and the WVU faculty advisor from any present and future claims, including negligence, property damage, personal injury, or wrongful death, arising from my voluntary participation in the activities of an organizational event.
- 4) As a Participant, I hereby release WVUSG and its faculty advisor from any present and future claims of gross negligence, reckless misconduct or intentional acts, arising from my voluntary participation in the activities of an organizational event.
- 5) As a Participant, I hereby release any landowners, his tenants or proxies from any and all present and future claims arising from my voluntary participation in the activities of an organizational event.
- 6) Furthermore, as a Participant, I hereby voluntarily waive any and all claims, both present and future against WVUSG arising from my voluntary participation in the activities of an organizational event including but not limited to, negligence, property damage, personal injury, and wrongful death.
- 7) I understand that the activities of an organizational event involve certain risks, including but not limited to, the possibility of myself falling, falling debris, drowning, hypothermia, or death by which damage or injury to my property and/or person may result.
- 8) I understand that equipment that I use such as, but not limited to: ropes, lights, harnesses, head gear, and vertical gear, could fail. I understand that when using borrowed and/or "used" equipment, I assume the risk of failure of the equipment. I understand that I should provide my own equipment. I understand that I am responsible for the proper use of equipment. By using any/all borrowed or "used" equipment, I assume the responsibility for knowing its proper use. Therefore if any equipment that I use fails, I am fully liable and responsible for any damage, injury or death to my person or property that may result.
- 9) I understand that the activities I engage in, while considered safe, do pose a certain amount of risk and that it is my responsibility to understand said risks before engaging in activities. To that end, I understand it is my responsibility to learn the proper techniques and my own limitations. Furthermore, I understand that I can at any time elect to not participate in any individual activity or portion thereof, without worry of repercussion.
- 10) I have carefully read the foregoing release and know the contents thereof, and I sign this release as my own free act, fully understanding that by doing so I am giving up my legal rights and/or remedies which may be available to me.

## PARTICIPATION AGREEMENT FOR THE WVU STUDENT GROTTO

The WVU STUDENT GROTTO involves strenuous physical activity. <u>Health professionals recommend</u> that all participants complete a physical exam or have a doctor's approval prior to beginning any exercise program and strongly urge all participants over the age of 45 to have a graded exercise test prior to beginning any exercise program.

Participation in the WVU STUDENT GROTTO involves strenuous physical activity including running and cardiovascular training. Possible injuries include, but are not limited to, muscle strains, back injuries, sprains, and more rarely, broken bones, strokes, cardiac malfunction, or other types of catastrophic injury. All participants must assess their physical condition and the possibility of injury.

The safe conduct of any group activity, such as the WVU STUDENT GROTTO, is dependent upon the individual actions of each member of the group. The participant has an obligation to refrain from dangerous or disruptive activity that might endanger the participant or any other member of the group. The use of drugs, alcohol, or any other substances that might be dangerous or detrimental to the participant's performance as a member of this organization is strictly prohibited. In addition:

- A. The undersigned understands that he/she is fully responsible for any and all medical expenses that he/she might incur as a result of his/her participation in any of the WVU STUDENT GROTTO activities.
- B. The undersigned certifies that he/she has adequate medical/hospital insurance coverage that will cover any and all medical expenses resulting from his/her participation in any of the WVU STUDENT GROTTO activities.
- C. The undersigned agrees that any travel conducted in conjunction with WVU STUDENT GROTTO activities is voluntary and discretionary. THE UNIVERSITY DOES NOT ASSUME ANY LIABILITY FOR SUCH VOLUNTARY TRAVEL.
