-----proposed changes to ISS Bylaws-----

Chapter I.A.2.

Conduct business only when at least more than half of all directors are present in person, and at least three fourths of all directors are Present in person, or by electronic means.

Chapter II.

- B. Each Elected Director shall:
  - 2. Serve a term of two four years.

5. A Director may be removed by two-thirds majority vote of the Board of Directors if she/he acts in a manner detrimental to the ISS.

#### **CHAPTER III - PRESIDENT**

The President of the Board of Directors shall:

B. Serve not more then two consecutive terms.

H. Verify that member's ballots have been accurately counted by the Vice President.

#### **CHAPTER IV - VICE PRESIDENT**

The Vice-President of the Board shall:

- I. Serve as the membership liaison between ISS members and the board by performing the following duties:
  - 2. Approve applications for membership for individuals meeting the conditions described in Chapter VIII Membership of the ISS Bylaws.
  - 23. Maintain the membership list for all members

#### Chapter VII.A.

Board Actions 2003. Membership is \$5.

## **CHAPTER VIII - MEMBERSHIP**

- A. Membership in the ISS will require an individual to agree to the purposes of the ISS and:
  - 1. Shall be granted on application in writing or in person to the ISS, citing sufficient evidence that the applicant supports the purposes of the ISS.
  - 2. Is not limited to residents of Illinois.
  - Have nominating and voting privileges only for election of directors, and as provided in the Constitution and Bylaws.

A. Membership in the ISS is determined by vote of the Board of Directors.

**CHAPTER XIV - DATA ACCESS** 

- B. The Board shall appoint a 3-member Data Request Committee to review information requests. The appointees shall serve one-year terms. The committee must be unanimous in their decision to approve the information request. If the request is denied, appeal can be made to the Board. Requests for large amounts of data will also require approval of the Board. The committee will track requests and the history of use of information. Qualitative information may be given out by a single member of the committee.
- C. All data ownership rights will be retained by the ISS. Requesters must sign a confidentiality agreement saying that they may not disseminate this information without written permission of the committee. Wherever applicable the requester must make a report of findings to the ISS in a timely manner. The cave catalogs complete or partial, do not belong to the requester and must be turned in when issued an updated one for the same area. Further restrictions may be imposed by the **Board Data Request Committee**.
- H. The **Board** Data Request Committee shall consider all data requests from organizations with a Memorandum of Understanding (MOU) with the ISS in such that the dissemination of data shall be in compliance with the MOU.
- I. The Board Data Request Committee when considering requests by a contributing member of the ISS will consider the fact that the requester has contributed to the database to be a significant factor in favor of granting the request. A "contributing member" is defined as a member of the ISS who has previously submitted original cave locations, original maps, or other original data of scientific value to the ISS database.
